**ORDINANCE NO. 220**

**AN ORDINANCE AUTHORIZING CHRISTIANA BOROUGH,  
LANCASTER COUNTY, PENNSYLVANIA TO ADOPT AN ADDENDUM TO  
THAT CERTAIN INTERGOVERNMENTAL AGREEMENT WITH ATGLEN  
BOROUGH, CHESTER COUNTY, PENNSYLVANIA, FOR THE PURPOSE OF  
PROVIDING POLICE SERVICES TO ATGLEN BOROUGH**

WHEREAS, Christiana Borough, Lancaster County, Pennsylvania and Atglen Borough, Chester County, Pennsylvania (collectively the "Municipalities"), are political subdivisions in adjacent counties;

WHEREAS, the Municipalities desire to adopt an Addendum to the Intergovernmental Agreement Christiana Borough approved by Ordinance 217 on March 27, 2013, and signed on March 27, 2013, under which Christiana Borough agrees to provide police services within Atglen Borough to and for the Borough (referred to herein as "The Police Services Contract");

WHEREAS, pursuant to the provisions of Chapter 23, Subchapter A, Intergovernmental Cooperation, of the General Local Government Code, 53 Pa. C.S.A. §2301, et. seq. (Intergovernmental Cooperation Law), a municipality may enter into an Intergovernmental Cooperation Agreement under the passage of an Ordinance by its governing body;

WHEREAS, the Intergovernmental Cooperation Act provides that any joint cooperation agreement shall be deemed enforced as to any municipality when the same has been adopted by Ordinance by all cooperating municipalities; and

WHEREAS, Christiana Borough desires to enact such an Ordinance.

NOW, THEREFORE, BE AND IT IS HEREBY ORDAINED AND ENACTED by the Borough Council of Christiana Borough, Lancaster County, Pennsylvania as follows:

***Section 1.***

The caption of and recitals to this Ordinance are set forth above and are incorporated herein by reference.

*Section 2.*

Christiana Borough hereby approves entering into an Addendum to the Police Services Contract, a copy of which is attached hereto and incorporated herein by reference (and which shall be filed with the Minutes of the meeting at which this Ordinance was enacted) with the intent and effect that Christiana Borough shall be bound by the Agreement.

*Section 3.*

This Borough is authorized to enter into the Intergovernmental Agreement for the purposes contained therein. This action is to be taken by the officials or employees of the Borough designated for this purpose, pursuant to general or specific instructions issued by the Borough Council.

*Section 4.*

As required by the Intergovernmental Cooperation Act, the following matters are specifically found and determined:

- A. The conditions of the Agreement are set forth in the Intergovernmental Agreement/Police Services Contract referred to in Section 2.
- B. The Intergovernmental Agreement/Police Services Contract shall commence on April 1, 2014 and continue through March 31, 2015. At the expiration of the initial term, the Agreement shall automatically renew for successive 1-year terms unless terminated in writing by either Atglen Borough or Christiana Borough, provided that the termination is in writing and is received by the other party at least thirty (30) days prior to the effective date of termination.
- C. The purpose of the Agreement is for Christiana Borough to provide police services to Atglen Borough as permitted under the Borough Code.
- D. The costs and financing associated with the police services are set forth in the Police Services Contract.

E. No change in the existing organizational structure of the Christiana Borough Police Department is necessary to implement this Agreement.

F. The Intergovernmental Agreement does not contemplate the purchase of any real or personal property.

**Section 5.**

This Ordinance shall be effective on the date of the adoption of the Ordinance by the last of the municipalities approving the Addendum to Intergovernmental Agreement/Police Services Contract.

**Section 6.**


In the event any provision, section, sentence, clause, or part of this Ordinance shall be held to be invalid, illegal or unconstitutional by a Court of competent jurisdiction, such invalidity, illegality or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses or parts of this Ordinance. It is the intent of the Borough Council that the remainder of the Ordinance shall be and shall remain in full force and effect.


**To An Agreement Between the Borough of Christiana, Lancaster County,




